

## Terms and Conditions of "Up to HKD300 instant discount on Japan accommodations bookings at Rakuten Travel" Offers ("Offers"):

- 1. The promotion period of this promotion is from 1 Sep 2024 to 31 Oct 2024 (both dates inclusive) ("Promotion Period").
- 2. The Offers only apply to customers holding Principal Card or Supplementary Card of the credit card or Co-brand card ("Eligible Card") issued by Dah Sing Bank, Limited ("Bank") ("Eligible Cardholders").
