

Terms and Conditions of Dah Sing Sanrio Credit Card "Klook Instant Discount of designated attractions":

- 1. The promotion period of the Promotion is from 1 Nov 2025 to 30 Jun 2026 (both dates inclusive) ("Promotion Period").
- 2. The Promotion is only applicable to cardholders holding principal card or supplementary card of Dah Sing Hello Kitty Credit Card or Dah Sing MINNA NO TĀBŌ Credit Card ("Eligible Card") ("Eligible Cardholder(s)") issued by Dah Sing Bank, Limited (the "Bank").
- 3. The Eligible Cardholders must settle full payment with Eligible Card to enjoy the Promotion. The Promotion is not applicable to all transactions conducted via eWallet or third-party mobile payment applications / platform, including but not limited to AlipayHK, PayMe, Tap & Go, WeChat Pay HK, Apple Pay, Google Pay, Samsung Pay.
