

Terms and Conditions of Dah Sing Sanrio Credit Card "Klook Instant Discount of designated attractions" :

1. The promotion period of the Promotion is from 1 Nov 2025 to 30 Jun 2026 (both dates inclusive) ("**Promotion Period**").
2. The Promotion is only applicable to cardholders holding principal card or supplementary card of Dah Sing Hello Kitty Credit Card or Dah Sing MINNA NO TĀBŌ Credit Card ("**Eligible Card**") ("**Eligible Cardholder(s)**") issued by Dah Sing Bank, Limited (the "**Bank**").
3. The Eligible Cardholders must settle full payment with Eligible Card to enjoy the Promotion.
